CODE OF CONDUCT & CONDITIONS OF ENTRY

Australian Warrior Fitness (AWF) is a multi-use recreational facility that offers a variety of services, programs, and events for the enjoyment of its members and visitors. AWF Provides recreational services in accordance with 139A of the Competition and Consumer Act and s5K of the Civil Liability Act 2002 (NSW)

We support a culture of Workplace health and safety for persons in and around our facility. We respect peoples individuality and diversity and will provide equal and fair treatment to all without discrimination.

The following Code of Conduct & Conditions of Entry sets forth expectations for all members, participants and visitors who use the facility for any purpose.

Participants and visitors must adhere to the following:

- Participants under 16 years must be supervised by a parent or guardian who agrees to be bound by these terms and conditions
- The weight limit for participants is 150 Kg
- The height limit for participants is 2.1m
- Participants must be in good health free from any adverse medical conditions.
- Act with courtesy and professionalism at all times.
- Respect peoples individuality and diversity
- Must comply with requests and direction from AWF staff, officials, instructors, and facilitators at all times.
- Comply with any rules and guidance set forth for the particular obstacles, programs, events, or training sessions
- Wear proper fitness attire; shirts and shoes are required at all times

Participants and visitors must refrain from:

- Aggressive behaviour in any form, including physical abuse, verbal abuse, threats, intimidation, harassment, coercion and/or conduct which threatens or endangers the health or safety of any person.
- Rude or argumentative behaviour with staff, officials, and instructors or other participants or visitors.
- Disrupting or obstructing any training program, event or class.

- Lewd, obscene or indecent conduct or expression, including profanity, or offensive remarks.
- Any action which constitutes an attempt to inflict, or the actual infliction of, or injury to, other participants and/or staff.
- Wilful damage or destruction to the facility, equipment or property.
- Forgery or sharing membership cards for access to the facility or access to programs, services or classes.
- Unauthorized entry to restricted areas such as kids party room, members lounge or any other area from time to time designated by AWF staff.
- Unauthorized adjusting of any obstacles or gym equipment including audio visual equipment.
- Photography and video recording of participants or visitors without prior approval of participants being photographed or recorded and without prior approval from an authorized staff member.
- Unauthorized commercial activity – no person is allowed to post, advertise, instruct in private lessons or solicit individuals in the facility for personal services or for personal businesses that is not directly affiliated and approved through AWF
- No drugs or alcohol are permitted on the premises and members or visitors must not be under the influence of drugs and/or alcohol at any times whilst on the premises
- Smoking is not permitted on the premises.

Enforcement

All participants and visitors are required to report any violation of this Code of Conduct to an AWF staff member immediately.

The above Code of Conduct will be enforced by the staff, officials, instructors and facilitators whose authority shall prevail in the immediate situation. Management reserves the right to refuse entry, cancel a membership or request a member or visitor to leave the premises, if the member does not behave in a responsible manner, or does not adhere to the general conditions of entry.

- Violations of the code will at the absolute discretion of AWF staff result in all or some of the following actions, including, but not limited to:
 - Verbal warning
 - A suspension of membership or access to the AWF facility for a specified period of time
 - A permanent Ban from the facility
 - Disqualification from competition/s

No refunds will be given as a result of any action incurred for the above violations.
